1ST ANNUAL DODGE HOUSE SHOOTOUT

VENDOR CONTRACT DODGE CITY ROUNDUP, INC.

THIS CONTRACT is made and entered into this _____ day of _____, 2011, by and between DODGE CITY ROUNDUP, INC., a Kansas Corporation, hereinafter referred to as ROUNDUP, and _____, hereinafter referred to as VENDOR.

IT IS UNDERSTOOD that ROUNDUP will put on a Dodge House Shootout, June 11, & June 12, 2011.

VENDOR is in the business of selling _____ and wishes to sell such products as a vendor, during said event. ROUNDUP is agreeable to such proposal, and this contract is made for the purpose of formalizing the agreement between the parties.

ROUNDUP agrees and contracts with VENDOR as follows:

- A. To permit VENDOR to sell the above listed products on the rodeo grounds in Dodge City, Kansas, on the dates stated above. No VENDOR shall have exclusive rights to the selling of product (s).
- B. The Vending stand shall be within the chain link fence, but outside of the rodeo arena, at a spot designated by ROUNDUP.
- C. Vendor vehicles, campers or motor homes cannot be parked inside the fenced area. If you need to drive in to unload you will need to have your vehicle out of the vendor area by 9am. Also, no camping allowed on the rodeo grounds, inside or outside of the fence. Information on campground facilities is available from the Dodge City Convention & Visitors Bureau, 4th & Spruce, Dodge City, KS 67801 or be calling them at (620) 225-8186.
- D. You may set up your Vendor booth on Friday, June 10, from 10 AM to 9 PM, and on Saturday, June 11 from 8AM to 10am. If you need to set up at other times, call the Dodge City Roundup, Inc. office at 620-225-2244 or call Dorothy Briseno @ 620-338-2464.
- E. Vendor will provide vending equipment, and will remove the same from the rodeo grounds immediately after the area is cleared out, following the Sunday, June 12 at 6pm performance. You will be charged \$250.00 if you tear down and leave early UNLESS YOU HAVE MADE PRIOR ARRANGEMENTS with the Vending Chairman.
- F. ROUNDUP will not provide any of the merchandise to be sold at such vending stand, nor will it furnish any personnel to sell the same.
- G. ROUNDUP will furnish no insurance coverage of any kind for VENDOR, nor will ROUNDUP have any responsibility for reporting sales of merchandise for Kansas retailer's sales tax purposes or income tax purposes, nor will it have any liability or responsibility for payment of retailer's sales taxes, income taxes, or any other tax whatsoever.
- H. ROUNDUP will furnish no security personnel to guard merchandise, supplies or equipment, and ROUNDUP shall have no liability to VENDOR for thefts or merchandise, or losses by fire, windstorm or other causes.

- I. VENDOR may place one (1) sign only on the vending stand, which shall be in good taste, and shall be subject to approval by ROUNDUP. VENDORS located under the grandstand may NOT put any signage on the OUTSIDE of the grandstand booths. VENDOR shall not be entitled to a full or partial refund due to rain, wind, other inclement weather, or any other act (s) of God.
- J. The duration of this contract is limited to the above dates.
- K. VENDOR shall not display or offer for sale any merchandise that Dodge City Roundup deems derogatory, vulgar, or foul smelling.
- L. All Food menus must be pre-approved by Dodge City Roundup.

ROUNDUP RESERVES THE RIGHT TO TERMINATE VENDOR AT ANY TIME BECAUSE OF MISREPRESENTATION OF PRODUCTS OR FOR NOT COMPLYING WITH THIS CONTRACT. IF VENDOR IS TERMINATED, THE MONEY PAID BY VENDOR IS NON REFUNDABLE.

VENDOR also agrees and contracts with ROUNDUP as follows:

- M. To pay to ROUNDUP, a rental fee for the right to sell merchandise at the vending stand, and for the use of the space on the ROUNDUP Arena Grounds. The total rental fee of \$_____, is due upon the signing of this contract, and must be returned with this signed contract. Your vendor space will not be reserved until the rental fee is paid to and received by ROUNDUP. The Booth fee will not be refunded for any reason.
- N. VENDOR agrees that before leaving the grounds after June 12, 2011, performance, VENDOR shall pick up and remove any all papers, other trash or debris, in the vicinity of the vending area. VENDOR also agrees to remove all unsold merchandise, supplies, equipment, and other personal property from the grounds.

All matters arising from said contract not specifically agreed to herein shall be settled and agreed to between the respective parties, to the satisfaction of both. Also, the laws of the state of Kansas shall apply.
